3. The Contractor will provide adequate insurance coverage in the form of Property Damage and Bodily Injury. *A certificate of the Contractor's current insurance policy must be provided to Drumore Township upon award of bid or your bid will be disqualified.*
4. Services to be billed monthly to the Township. **(Note: Invoice must be received prior to the first Thursday of the month for payment approval at the Board of Supervisors regular business meeting or payment will be delayed until the next regular business meeting.)**
5. Contract will expire one (1) year from date of award.
